Subject: AMERICAN SAMOA ENTRY PERMIT WAIVER COUNTRIES

A. All previously released notes and memorandums pertaining to subject matter are superseded and void.

1. Effective immediately the following are list of countries that are not required to have an Entry Permit to enter American Samoa. These countries are listed under the States Department Visa Waiver Program. Travelers from the listed countries must hold a Machine Readable Passport in order to travel to American Samoa. Travelers must hold a non-expired passport and the expiration date must not be more than 6 months from the passport expiration date. Travelers are authorized to transit through American Samoa or stay up to 30 days under a tour visa. While in American Samoa travelers are not authorized to be employed. To request more than 30 days stay in American Samoa, Travelers must report in person with his/her passport to the Immigration Office for extension approval / authorization.
